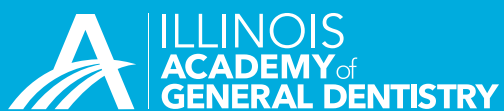

**Speaker Biography:** Dr. Larry Williams graduated from the University of Tennessee College of Dentistry in 1982. He recently retired from 30 years of Service in the United States Navy Dental Corps where highlights of his Navy career included serving as Navy Region Midwest Public Health Emergency Officer, development of the National Action Plan for Tobacco Cessation, and creation of the Affordable Care Act's National Prevention Strategy. During his Navy career, Dr. Williams attended the Department of Defense Combat Casualty Care Course and received considerable training in disaster preparedness. He has been active in the Medical Reserve Corps, Citizens Corps, and various Emergency Preparedness planning groups at local state, and Federal levels. He currently serves as an Associate Professor at the Midwestern University College of Dental Medicine- Illinois. Dr. Williams is a Master in the Academy of General Dentistry and holds board certified status in the American Board of General Dentistry.



**Course Summary:** Life-threatening emergencies can happen fast and emergency responders aren't always nearby. Do you want to stand by and see people suffer because you do not know what to do? Why get involved when someone is badly injured? According to a recent National Academies of Science study, trauma is the leading cause of death for Americans under the age of 46. **Speaker Biographies:** *Dr. Nový* is the Director of Practice Improvement at the DentaQuest Institute, and an adjunct associate professor of restorative dentistry. He serves on the ADA Council of Scientific Affairs, acts as the chair of the CAMBRA coalition, is a member of the AGD and a clinical evaluator for the Catapult Group. The California Dental Association Foundation presented him with the Dugoni Award for "Outstanding contributions to dental education," and in 2009, the American Dental Association awarded Dr. Nový and his office the title, "Adult Preventive Care Practice of the Year."



### Course Description:

Offensive dentistry. Let's face it, sitting through a lecture about dental caries or caries risk assessment isn't appealing (in fact it sounds downright boring). However, the science of clinical cariology is beginning to have an impact on restorative techniques and technology. Streptococcus mutans has more to fear than a rheostat, now that we're armed with salivary diagnostics and bioactive materials.

### **The Un-Holy Trinity of Function: A New Approach to the TMJ, Oro-Facial Pain, and Functional Occlusion**

**Speaker's Biography:** Dr. Horowitz received his undergraduate degree from the University of Pittsburg and his DMD degree from the Medical University of South Carolina. He completed a general practice residency at Mountainside Hospital in Montclair, NJ. He founded the Carolina Center for Cosmetic and Restorative Dentistry, a multi-disciplinary group practice in the Conway/Myrtle Beach, SC area. An admitted CE junkie, he has earned AGD Fellowship. He is a key opinion leader and lecturer for many professional groups and organizations.

**Course Description:** We have all heard the arguments. Does the occlusion cause the joint problem or does the joint cause the occlusal problem? What role do facial patterns and muscles play? ## Root Canal Treatment on the Cutting Edge: Simplicity and Efficiency

Dr. Landwehr received his undergraduate degree from the University of Wisconsin, his DDS from the University of Minnesota, his Oral Pathology degree from Ohio State University and his Endodontic training from the University of Michigan. Since returning to his native Wisconsin in 1999 he has provided exemplary care to patients and maintains a full time practice at Capital Endodontics in Madison, Wisconsin.

**Course Description:** Endodontic success is dependent on a variety of interrelated factors. This seminar will provide a comprehensive review of endodontic diagnosis and the limitations of pulp testing. A short refresher on endodontic anatomy will help the clinician choose the most predictable cases. After the establishment of a glide path, the clinician is faced with many options to create the final shape and cleanliness within the root canal system. An evidence-based review of cutting edge instrumentation options, with special emphasis on instrument design and mechanical movements, will be covered. Additionally, enhanced irrigation protocols will be explored, prior to presenting state-of-the-art obturation and restorative techniques.

### Course Objectives:

The participant will learn:

- how to increase the accuracy of endodontic diagnosis by understanding the limitations of pulp testing

- the design features and working characteristics of the most commonly used root canal instrumentation systems to increase clinical efficiency and predictability
- the most advanced irrigation protocols and techniques for the elimination of bacteria from the root canal system
- how to create the most biologically sound, dense and repeatable 3-dimensional filling of any root canal anatomy

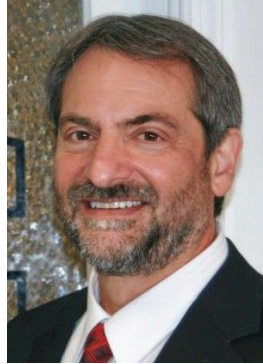

## Implant Assisted Removable Prosthodontics

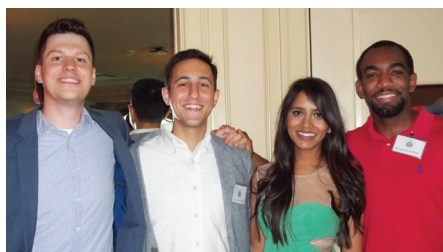
